#### \*\*\*PARKING AND ACCESS INSTRUCTIONS\*\*\*

## **President's Message**

Summer is nearly over, and your Civic Federation board is hard at work getting ready for what we believe will be a busy and illuminating autumn. That starts on the day after Labor Day with our annual Candidates' Forum at 7:00 p.m. on Tuesday, September 3 in the Hazel Auditorium at Virginia Hospital Center.

Three local races are on Arlington's November ballot. These elections will fill seats in the House of Representatives, the County Board and the School Board. Four candidates have declared for each position.

That's a lot of races, a lot of candidates, a lot of issues to cover and too little time to do it. We're going to allot a bit more than half an hour to each contest, because we have other business to transact, most notably voting to welcome two new member groups. These are Arlington's well-respected Arlington Neighborhood Village

organization and the Northern Virginia Affordable Housing Alliance, which merged on January 1 with former CivFed member organization Alliance for Housing Solutions.

For the Candidates Forum, I'll moderate the County Board race first; our Schools Committee chair Todd Truitt will lead the School Board debate, and finally I'll return for the House of Representatives race. We will try to focus our questions on the most pressing issues, and I would be grateful to hear your emailed thoughts on what you believe are those key questions. You'll see a notice below with details about our updated CivFed picnic plans. The event will be held at Fort Scott Park on Saturday, September 14, from 12:00-4:00 p.m. As I have mentioned before, we want to see how interested our members are in a Fall social event to match with our revived Spring banquet. We hope you will join your Executive Board for what promises to be a fun family event that also offers good networking opportunities.

The CivFed forum on Arlington's form of government, flowing from the well-received recommendations of our TiGER committee in 2023, has now been rescheduled for October 15. Please note the time and place in the article below.

Other committee announcements and meetings are also scattered throughout this newsletter. We are very proud to have contributed to the revival of our vital CivFed committee structure, and evidence of its development will be on full display at our October 8 and November 12 general membership meetings.

As you'll see in the next paragraphs, the subjects we will address in these meetings is both challenging and vitally relevant for Arlingtonians in every part of the county. I encourage you to engage with us as we explore our most significant issues and seek consensus on solutions.

I won't pretend that our agenda is not ambitious. But if we don't try to find solutions to problems in areas such as housing, parks and green space, residential and commercial zoning, community gathering spaces, climate change resilience and other priorities, we certainly won't be able to make cogent, consensus-driven recommendations for county action.

We are trying hard to make our presentations accessible and easy to digest even for members who are not regularly engaged with them, and we're developing some innovative ways to do that. I hope you'll give this a try with us. More information is offered below.

I'm looking forward to seeing you all on September 3. Meantime, have a safe and happy Labor Day weekend.

# Form of Government Subcommittee of the Legislation Committee

It's been quite a month for the Form of Government subcommittee. We had been invited by the County Board Chair to hold a meeting on August 19 to cover both the 'Son of TiGER' advocacy of the CivFed and the planned bill by Delegate Hope to level up Arlington's authorities to match those of its peer jurisdictions. Early in August, Delegate Hope made it clear that he didn't feel that the overlap between the two initiatives was great enough that we should cover them together - that the TiGER effort was both much broader and less tightly focused than his bill. After consulting the with Board, we have postponed the intended meeting to October 15 at the Ellen M Bozman Government Center. We're going to do our best to provide a compelling roster of speakers and information to make a place for Form of Government

considerations in the Arlington 2050 document and in current decision making.

We hope you will come, or view it either as it takes place or in a recording. Also, we invite you to provide written input on the ideas identified in the preparatory document or on any other views you have on potential improvements in County government. For more information, see

CivFed Housing Committee Meeting September 19, 2024:

"Defining, Understanding, and Addressing Displacement as a Key to Good Housing Policy," 6:30-8:00 pm, featuring Michael O'Grady and Wells Harrell

Please join us September 19 at 6:30 pm for our monthly Housing Committee

meeting. The Committee welcomes two of its own, Wells Harrell and Michael O'Grady, to discuss residential displacement. Michael brings a Ph.D. in economics and public policy teaching expertise (as well as data crunching Arlington demographics) and Wells brings public policy experience as a federal attorney, the Chair of NAACP Arlington Branch's Housing Committee, and the Vice Chair of the County's Joint Facilities Advisory Commission.

For some years now, policy-makers have been grappling with how best to maintain growth, revitalize neighborhoods, and redress past inequities in housing, without displacing marginalized or low-income residents. Michael and Wells will define displacement and related concepts, help us understand the theoretical underpinnings of displacement and its drivers, provide relevant examples, explore data-gathering methods, outline approaches adopted elsewhere, and provide some recommendations for Arlington.

From 7:30-8:00, we will review the last iteration of our potential resolution recommending the county amend its methods of tracking housing stock and potential housing production to inform land use and zoning policy.

## **Membership Update**

The ACCF board reviewed two new membership requests from Northern Virginia Affordable Housing Alliance (NVAHA) and the Arlington Neighborhood Village (ANV), and determined their missions meet the requirements needed to become a member of ACCF. As such, our September 3rd meeting will include a General Membership vote to determine NVAHA's and ANV's membership status.

#### Arlington Neighborhood Village (ANV)

Arlington Neighborhood Village (ANV) was born from discussions among a small group of friends on how to remain in the community they love as they aged. Since 2014, ANV has grown from an idea among friends to a thriving village with over 440 members and more than 300 volunteers directly serving members. Volunteers provide rides to medical appointments, perform errands (grocery shopping, medication pickup), are friendly visitors and walking buddies; help with technology, and many more activities to reduce social isolation and form meaningful connections.

ANV serves all of Arlington with members ranging from 58 to 102 years of age, living in neighborhoods throughout the county, and with a diverse range of interests

and needs, cultural and racial backgrounds, and economic circumstances.

Our mission is to enable older adults to continue living safely, independently, with an enhanced quality of life in their own homes and communities as they age. ## Northern Virginia Affordable Housing Alliance (NVAHA)

Collaborate. Inform. Act.

In 2023, the Alliance for Housing Solutions, a 20-year-old Arlington non-profit and member of Civ Fed, and NVAHA, Northern Virginia Affordable Housing Alliance, decided to combine forces and merge as one NVAHA. They had been 'sister organizations' for many years, with NVAHA doing work similar to AHS, but in all 5 NOVA jurisdictions, including Arlington.

As of January 2024, AHS was dissolved and AHS's Arlington-specific work continues, under the new name NVAHA-Arlington Housing Alliance, or just NVAHA-Arlington. NVAHA-Arlington is a branch of the larger NVAHA, where we cover all the housing-related and affordable housing activity in Arlington County.


Affordable housing is about so much more than housing. At NVAHA, we approach our housing work through the lens of its broader societal impact at the local, regional and state levels. From advancing social equity to promoting shared prosperity, we know that public policies and financial investments to develop and preserve housing that's affordable yield returns that benefit us all.

NVAHA's mission is to increase the supply of and equitable access to affordable housing in Northern Virginia through education, advocacy, and community partnership. Our work includes public education about the need and benefits of affordable housing and overall housing supply in our community, housing policy development and consultation, convening of housing professionals and advocates, and policy advocacy itself. We are working to meet the diverse housing needs of Northern Virginia communities through alliances that are locally responsive and regionally united, such as here in Arlington.

And a note: Following our merger, we began a logo and website re-vamp that is close to completion.
