Dear CivFed members,

On behalf of your Civic Federation Board of Directors, I want to wish for each of our members a happy and safe holiday season. Over this period and into the new year, our schedule just got busier! I'll look ahead and explain the changes below.

Upcoming on December 10 at 7:00 p.m. in the Hazel Auditorium at Virginia Hospital Center is our annual session with Arlington County Manager Mark Schwartz.

While we have opportunities for engagement with Mark at roundtable sessions through the year and at our annual Board of Directors meeting with him each June, this is our only regular engagement with him when our entire organization is invited and involved. Given the challenges the county faces, this meeting is always interesting and informative. I urge you to join in person if you are able to do so.

We will also receive a general security update from Deputy Police Chief LaTasha Chamberlain.

In January and February, after discussions with members of the incoming Arlington County Board, we have made some changes to our schedule.

The County Board, including newly elected member J D Spain, will convene for its annual organization meeting on the evening of Monday, January 6. A highlight of these meetings is the presentation by each board member of their plans and hopes for the coming year. It's a very good introduction to the county's agenda for 2025.

Your Civ Fed board and the County Board will hold a joint work session in the County Board room on Wednesday, February 26 from 7:00 - 9:00 p.m.

November General Membership Meeting Outbrief

Our membership meeting addressed some of the most critical impacts of comprehensive planning in Arlington County. We included time for the audience to add their thoughts and suggestions, with membership involvement in the discussion a priority. Presentations included:

- Comprehensive Plan and General Land Use Plan (GLUP) Principles Context, presented by Nicholas Giacobbe, Vice President, ACCF. The presentation can be found here.
- 2. **Comprehensive Planning, Housing and Development (CPHD) 2024 Work Plan Highlights**, presented by Jackie Snelling, presenting on behalf of the Planning and Zoning Committee. The presentation can be found here.
- 3. **Framework for Comprehensive Plan and GLUP Review**, presented by Brian Harner, Chair, Planning and Zoning Committee. The presentation can be found here.

We also made meaningful progress on two ACCF Committee resolutions. First, we voted on the Public Services Committee Resolution on Climate Adaptation.

• A motion was made to approve the Public Services Committee Resolution on Climate Adaptation, that was reviewed in the October GM meeting, shared with member organizations, and updated based on ACCF Committee feedback. The motion was moved, and seconded. The Resolution on Climate Adaptation was approved by acclamation (Yeah = 39, Nay = 2, Abstain = 5). The approved resolution can be found https://example.com/here

The CivFed Planning and Zoning GLUP and Site Plan Subcommittee will meet on Tuesday, Dec 17 at 7:30 to identify work plan priorities and share concerns over County zoning and site proposals.

The agenda for this inaugural meeting of the subcommittee is:

- 1. Brief presentations by interested CA's on current County zoning and site proposals to densify and alter critical neighborhood characteristics. See links above presenting three presentations from the November 2024 CivFed meeting.
- 2. Discussion and documentation of common issues to pursue including recent proposals threatening decades of policies to preserve low density neighborhoods.

Background: The Planning and Zoning subcommittee on the General Land Use Plan (GLUP) is collecting information on Civic Association (CA) level experiences with the GLUP process for changing the GLUP and or zoning for a site and for the site plan process. We're starting with documenting experiences, and we are inviting participation by all interested CA leaders and any other interested members to discuss their experiences and recommendations for improvements. Empowering Communities in Site Planning: A Strategic Guide

Site planning presents exciting opportunities for communities to shape their neighborhoods' future. This guide reveals insights into how residents can effectively participate in the development process and ensure their voices are heard.

Understanding the Process. Development planning involves multiple stakeholders, including developers who submit preliminary plans and work with county staff. While well-resourced developers often employ land use attorneys to navigate the system, communities can level the playing field through strategic engagement.

Effective Community Strategies. Smart monitoring of local real estate news sources like the Washington Business Journal helps communities stay ahead of developments. Understanding the Site Plan Staff Report template enables productive engagement with CPHD staff, SPRC members, and county board members.

Innovative engagement approaches include: Creating private agreements with developers, Establishing memorandums of understanding with developers and constituencies, and Strategic lobbying during county board Open Office Monday meetings. An example of an Engagement Letter is here.

Critical Post-Approval Challenges. Even after site plan approval, developers can make changes outside the public process by having the Zoning Administrator approve modifications without community input. Also, staff by practice avoid citations for site plan violations, preferring to work it out with the developer; this leaves no public record of site plan violations.

Recommendations for Community Action. Demand Transparency by requesting early access to draft site plans. Insist on comprehensive public meetings in order to address plan inadequacies. Build strong community Strategic Alliances to engage developers before formal hearings. Develop written "Statements of Engagement" with developers to bring community-negotiated agreements to county hearings. Practice Persistent Advocacy by attending Open Door Monday meetings, and scheduling one-on-one meetings with board members and senior staff.

Path to Success. Through strategic engagement and persistent advocacy, communities become powerful voices in local development. By building relationships and maintaining active participation, residents can significantly influence the evolution of their neighborhoods.

Stay informed, stay engaged, and remember: your community's voice matters.

Join us on Thursday, December 5 at 7:30pm for an update from our guest speaker, Deputy Chief Giroux, who leads the Criminal Investigation Division. Chief Giroux will discuss crime trends, staffing recruitment and retention, and the license plate reader program currently under consideration by the Committee.



Residential Unit Tracker

WHEREAS Arlington County officials cite our **housing crisis** as well as objectives of its **Affordable Housing Master Plan of 2015** in its approach to most policies relating to preservation and production of housing units in Arlington County.

WHEREAS Arlington County, which makes up .75% of the MWCOG policy area and participates in the MWCOG 2020-2030 regional housing production goal process for establishing its share of the regional housing market needs (chart below depicts suggested breakdown of housing affordability and transit accessibility as percentages of the total goal):



Read more about the targets in COG's report, *The Future of Housing in Greater Washington*, and learn how COG is building on this work through its *Region United Planning Framework* for 2030.

WHEREAS Arlington County is guided by its AHMP implementation plan, the most recent iteration of which was published in 2022; and which shows a surplus of units at 50% of AMI and above (at then current levels) and a deficit of units below 50% of AMI (at then current levels);



WHEREAS Arlington County has taken numerous policy steps since 2005 to increase housing production, to include the <u>Affordable Housing Ordinance of 2005</u>;

WHEREAS Virginia HB 2046 signed on March 27 2023 requires Virginia localities over 3,500 to submit annual reports to the State summarizing their "housing policies, ordinances, or processes affecting the development and construction of housing." (HB 2046 Statewide housing needs assessment and plan (Bill language and history)

BE IT RESOLVED that the ACCF calls on Arlington County Board to define the housing needs through 2040 as [Arlington's share of MWCOG regional goals, including specific numbers that must be at 50% of AMI and below (see <u>AMI rates effective April 2024 here</u>) to clarify housing production potential with current zoning and land use, and to establish yearly goals for housing preservation and production to meet needs identified in the AHMP implementation and other housing

goals outlined in the General Land Use Plan. (See sample projections on attached pages from 2023 Pentagon Sector plan p. 27. (NOTE: The Pentagon City Plan has been revised since original passage, but the modeling from the original plan is illustrative of ways to track potential yield from all new zoning and land use amendments.)

Virginia Hospital Center Hazel Auditorium Parking and Access Instructions for General Membership Meetings

Reminder: Parking passes will be provided. Meetings are held in the 'Conference Center' depicted on the map below.


The VHC Director of Security has advised CivFed that we should begin to park in Parking Garage C (map below). You can then walk across to the Oncology entrance and gain admittance until 8 p.m. **After the meeting, you MUST EXIT via the Women's and Infant lobby.**


ENTER (until 8 p.m.): Zone C Ground floor Oncology entrance (only open until 8 pm, Monday-Friday)

- Sign into the visitor kiosks (need driver's license each time)
- Get visitor sticker and wear at all times when inside the hospital
- Take a right at the double doors by the visitor kiosks
- Take a right at the single door
- Go to elevators and take to lobby floor
- Exit elevators and go left to hall directly behind welcome desk in lobby
- Take a left at the single door and continue down the hall toward a set of double doors
- Go through double doors and go right
- Conference center auditorium is directly ahead

ENTER or EXIT (24/7): Zone C first floor Women's and Infant lobby entrance (please use this entrance to exit after 8 pm, open 24/7):

- Sign into the visitor kiosks (need driver's license each time)
- Get visitor sticker and wear at all times when inside the hospital
- Walk to hall directly behind the welcome desk in the lobby
- Take a left at the single door and continue down the hall toward a set of double doors
- Go through double doors and go right
- Conference center auditorium is directly ahead
